EATON India Foundation supported DEF Skill Development Training Centre, Puducherry


EATON India Foundation funded DEF Skill Development Training in Puducherry for two years project. The duration of the course is 2 to 3 months. The training includes Basic English Conversational, Basic IT Skills, Typing Speed, and General Skills. The objective of the mission is capacity building of the unemployed youth and delivering the quality skill training leading to meaningful employment

(Coaching Classes for Intermediate & Degree Students)

Deaf students need additional help in Indian Sign Language so they can understand and perform well in the courses they undertake. Keeping this in mind DEF established Coaching Classes for students doing various courses from the Board of Intermediate Education for Higher Education or through Annamalai University or Andhra University. A trained and experienced teacher enables these students to complete their curriculum and perform well in their respective courses.

Currently there are Deaf students from DEF doing Intermediate courses at the Senior Secondary level, as well as Deaf students pursuing their Bachelor of Commerce degree in Computer Application from both Annamalai University and Andhra University through DEF's Coaching Classes. Our teachers and coaches are equipped to aid any deaf students pursuing their education in Class 11 or 12, as well as those seeking their Bachelor of Commerce degree through Indian Sign Language and written English mediums.

VOCATIONAL TRAINING PROGRAM

The DEF- Skill Development Training conducts Vocational Training Program Courses and is a major wing of DEF. The courses conducted by DEAF ENABLED FOUNDATION includes: a. Basic IT Skill DEF is working towards providing quality computer education to all Deaf persons so that they can be a part of the Indian work force and play a constructive part in the development of our nd. The unique feature of our Computer Center is that our teachers and instructors are also Deaf and they teach the Deaf students through Indian Sign Language (ISL). DEF aims at creating a pool of talented IT workers from the Deaf community. It is our dream that every Deaf person passing out of this Center will be placed in companies of repute in the IT and other allied fields. We also encourage Deaf persons to take up self-employment. The Basic Computer Course and training in DTP helps the deaf student to become adept at working with a computer.

8th March 2021, Hyderabad



T-20 Cricket Tournament for the Deaf


27th February 2021, Hyderabad



- Providing online classes and giving out academic support for Deaf students.




